

Since July 2011 Dr. No has been on extended voyage which, as of August 3, 2013, has covered 14,000 nautical miles.

During these voyages, Dr. No burns 93 litres per hour (at 9 knots) with the shaft generator. At 10.3 knots, she burns approximately 110-120 liters per hour with the shaft generator.




